WE HEREBY UNDERTAKE AND ACKNOWLEDGE to the Owner at all times THAT:

1. The Owner is the sole and exclusive owner of the Confidential Information and we shall treat any and all Confidential Information in the strictest confidence.
2. We shall not divulge any and all Confidential Information to or permit it to come into the hands or to be or become available to any other persons whatsoever.
3. We shall not use any and all Confidential Information for any of our own purposes but only as we are directed to use it or any part of it by the Owner.
4. We shall take all reasonable steps as we are advised to take by the Owner to cause and ensure that any and all Confidential Information is kept in the strictest confidence.
5. These undertakings shall have full force and effect and shall operate at all times hereafter notwithstanding that we may subsequently cease to be engaged in discussions or dealings with the Owner.
6. The Owner reserves their rights in protecting any and all Confidential Information presented during the course of, or consequent to our dealings.
7. This agreement extends to the employees and any contractor or person who may be employed or contacted from time to time of the persons/corporation and are bound by the terms of this Confidentiality Agreement.
8. This agreement shall continue for a period of three (3) years beginning from the date in the Schedule. The owner may extend the period in which the Agreement operates, as an ongoing right, by giving written notice to the other parties as listed in the Schedule.
